In regard to the Articles for Presents, &c. it will be indispensably necessary that I should make choice of them myself, particularly as they must be selected so as to be acceptable to the different nations of the neighbourhood they are wanted for; and as finery is more the object than real goodness, much expense may be saved by such a measure ; and as a part. of them will take some time to complete, I should hope the order may be given for that purpose as early as possible.

I think it my duty to suggest the propriety of adding some trifling Lace Cord to the Slop Jackets for the Recruits; such an addition will be but triffing in the expense, but will doubtless prevent a comparison which the Recruits would make between their Dress and that of the Party.

REFERRING to my Letter of the 2nd January last, and to yours of the 4th ultimo, upon the subject of the Recruiting Depót intended to be established on the Coast of Africa, under the superintendence of Major Wingfield; I am to acquaint you, for the information of the Lords Commissioners of His Majesty's Treasury, that the Commander in Chief, in apprizing me of the establishment of the Depôt by his communication of the 1st November 1811, a Copy whereof is herewith enclosed, has stated it to be expedient to send out 500 Suits of Slop Clothing for the use of the Black Recruits expected to be raised in Africa.

As this Slop Clothing is required to be made up in a manner most suited to the habits and dispositions of the Africans, it has seemed to be advisable to permit the same to be prepared by Messrs. Pearse, under the direction of Major Wingfield; and I have given the necessary authority accordingly.

A Copy of the Estimate of the Price of the Articles, as furnished by Messrs. Pearse, is transmitted herewith.

I AM directed by the Commander in Chief to acquaint you, for the information of the Secretary at War, that with a view to the completion and augmentation of the West India Regiments by recruiting on the Coast of Africa, His Royal Highness the Prince Regent has been pleased, in the name and on the behalf of His Majesty, to approve of a Recruiting Depót being formed either at Sierra Leone or Goree, and placed under the command of Brevet Major Wingfield, of the 8th West India Regiment, with a daily pay of 15s. who is to be assisted by one Captain at 10s. per diem. Four Lieutenants, 5s. ditto.

From every Black Regiment in the West Indies. 2 Corporals.

In consideration of the nature of the Service on which it is intended to employ these Officers, it has appeared to His Majesty's Government to be absolutely essential that those who are placed permanently in Africa, should be encouraged by the Rates of Pay recom-mended in addition to their regimental situations; and care will be taken in the selection of Non-commissioned Officers, that the most trust-worthy from amongst those who speak the African Language, shall be appointed to the Depôt, the success of the measure depending in a great degree upon the explanation of the advantages attending the situation of a British Soldier, which such Black Non-commissioned Officers will be enabled to give their countrymen.

Major Wingfield will receive instructions to appropriate to the Service such eligible persons as may be found amongst Cargoes of Negroes captured under the Slave Abolition Act; but as it will be highly necessary to bring the Military Service into repute, by the encourage-ment of Voluntary Enlistment, the Prince Regent has approved that the Major shall be authorized to disburse a Bounty of Eight Guineas for each Recruit, under such regulations as may leave at least Three Guineas for his equipment or necessaries.

The usual full Bounty of Fifteen Guineas is not proposed, in the hope that the sum of Eight Guineas will answer the purpose, under the idea that such trifling articles of inducement, more acceptable to the Negroes than Money, may be furnished by a portion of the latter sum.

This consideration, however, and many others which cannot possibly be provided for or foreseen in the arrangement of so novel an establishment will be subject to such subsequent

modifications as may be attendant upon the experience of execution. It will be necessary that Major Wingfield, who will proceed direct from this country to the Coast of Africa, should be authorized to take out with him about 500 Suits of Slop Clothing, and other articles of necessaries for the equipment of the Recruits; and the Commander in Chief requests that the necessary orders may be given for the provision of these Stores accordingly.

In the performance of the duties which will in consequence devolve upon you, His Royal Highness has directed that you shall be assisted by

1 Captain,

4 Lieutenants,

1 Paymaster,

1 Adjutant,

1 Serjeant Major,

1 Serjeant 2 Corporals from every Black Regiment in the West Indies.

You will be allowed the daily Pay of Fifteen Shillings, in addition to that of your Regimental Appointment; the Captain will in like manner be allowed the additional Pay of Ten Shillings, and the Lieutenants of Five Shillings each, while detached upon this duty.

You will be allowed to appropriate to the Service of the West India Regiments, such eligible Persons as may be found amongst Cargoes of Negroes, captured under the Slave Abolition Act; but as it is deemed an essential point to encourage voluntary enlistment as much as possible, the Prince Regent consents to a Bounty of Eight Guineas being disbursed for each Recruit, under such Regulations as may leave at least Three Guineas for his Equipment in Necessaries.

The Lords Commissioners of His Majesty's Treasury have authorized the sum of Four Thousand Nine Hundred Pounds to be issued to you, to defray the expense of the Presents to be taken out for the Native Chiefs, and of the Articles of Necessaries for Recruits, agreeably to the List enclosed in your Letter of 18th November 1811, addressed to Colonel Torrens; and the necessary steps will be immediately taken for providing Five Hundred Suits of Slop Clothing for Recruits, upon your transmitting a specification of the Articles, and of the Prices at which the same can be procured.

Instructions for the Information and Guidance of the Paymaster of the Recruiting Depôt at Sierra Leone, on the Coast of Africa.

YOU are to issue Pay to such Officers and Men as are attached to the Depôt by the proper Authority, and to such Recruits as shall be enlisted under the Regulations by which the Depôt is established ; and you are to be guided in all points relating to the issuing and charging of Pay and of the Allowances to Officers, by the existing Regulations, so far as the same are applicable thereto.

The Sums necessarily required for the Pay of the Commissioned Officers belonging to any Regiments, are to be drawn from the Agents of the Regiments thereof; and those for their Special Ailowances, for the Pay and Allowances of Officers belonging to the Depôt only, for your own Pay, and for that of the Non-commissioned Officers and Recruits; for all other Services authorized by the Secretary at War to be charged in your Accompts with this Department, are to be drawn from the General Agent for the Recruiting Service, John Ridge, Esq. Charing-cross, London.

Your Bills are to be drawn according to the Rules laid down for Regimental Paymasters; but are to be approved and signed by the Officer commanding the Depôt, as established in regard to the Bills of District and Depôt Paymasters.

As to making up and transmitting the Monthly Estimates, Adjutant's Rolls, and Quarterly Accompts, and to all other points not specially mentioned herein, you are to be governed by the instructions for a Regimental Paymaster, so far as the same may be properly considered to be applicable thereto.

As the Non-commissioned Officers and Drummers attached to the Depôt are to be furnished from the West India Regiments, you will take care always to specify opposite to their Names in each of your Pay Lists, the Corps to which they respectively belong.

The Expenditures and Receipts, on account of Levy Money, are not to be accounted for in your Pay Lists,-a separate Statement thereof being to be rendered by the Commandant of the Recruiting Depôt.

I have, &c.

I HAVE the honour to enclose to your Lordship, two Letters addressed to me by Lieutenant Hyde, commanding the African Recruiting Depôt, on the subject of some Disallowances which have been made by the Superintendents of Military Accompts; and to offer

to your Lordship my opinion on the same. The late Brevet Major Wingfield on his arrival here, informed me that he had your Lordship's concurrence to make such appointments of Non-commissioned Officers, as the nature of the service might require; the novelty of it rendering it impossible to devise or settle a stated arrangement in England; in consequence, he appointed the Non-commissioned Officers alluded to by Lieutenant Hyde.

After Brevet Major Wingfield was displaced in the Command of the Depôt, as the Recruits increased, and owing to a great proportion of the Non-commissioned Officers from the West India Regiments having been sent with Recruits to Barbadoes, added to the necessity of employing some of the remainder on the Recruiting Service, up the River and in this Colony, the other two Non-commissioned Officers were appointed; these were absolutely necessary to assist the regular Non-commissioned Officers, who for some time had the entire charge of the Depôt in consequence of the sickness of the two Officers. Under these circumstances, I hope your Lordship will be pleased to sanction the expen-

diture on that head, and the appointment of such Non-commissioned Officers as may be necessary to carry on the duty of the Depôt.

Necessary to carry on the duty of the Depot. With regard to the Allowance drawn by Lieutenants Hyde and Gregg, as a Committee of Paymastership, it was done by my consent, on the death of the late Mr. Eastlake, under the 10th Article of the Regulations, page 215. Chance of service placed Lieutenant Hyde in the situation of Commanding Officer and Adjutant, but as I was led to expect a reinforce-ment of Officers for the Establishment, and amongst them a Captain, it appeared to me to be the support to conduct the Depot Accounts be the regular channel to conduct the Depôt Accounts.

I beg leave to state to your Lordship, that Lieutenants Hyde and Gregg have had a most laborious task to perform, since the November of last year; being the only Officers at the Depôt, during the greater part of the time, they have had to manage and pay a body of people nearly equal to three Companies, without any allowance whatever on that account. All Returns, Accounts, and Public Documents relating to the Establishment, have been made out by Lieutenants Hyde and Gregg, and most of these in manuscript, owing to the want of printed Forms; much of this they had to wade through, after recovering from dangerous and debilitating illnesses, of which Lieutenant Hyde still labours under.

The difficult and novel situation these Officers have been placed in, I trust will induce your Lordship to afford them every indulgence in your power; and until a regular Esta-blishment is formed to conduct the African Recruiting, that you will be pleased to sanction their drawing the allowances in question.

I EEG to offer the following Statement for your perusal, and trust if it meets your approbation, that the same may be communicated to the Right Honourable the Secretary at War.

Agreeably to your Orders, I received the Public Papers of the late Paymaster, John Eastlake, and there being but one Officer (Lieutenant Gregg of the 6th West India Regiment) at the Depôt, I thought it most proper that we should act as a Committee, and accordingly drew the usual Allowance of 10s. per diem granted in such cases. The Superintendents of Military Accompts have notified to Lieutenant Gregg, that that Allowance cannot be granted unless sanctioned by the Secretary at War; and if granted, his Extra Allowance (on this Service) must cease.

I beg leave to observe, that from the multiplicity of business it is impossible the duty of Paymaster can be performed by one Officer at this Post; and where two must share in the trouble, it is but just they should partake in the emolument, which if curtailed, would be a very small portion to each, and particularly so where we do not receive the usual Allowances granted to Officers paying and commanding Companies.

I trust you are convinced of the justness of our claims to these Allowances, and beg you will be pleased to represent it in such terms as will ensure a continuance of them.

I HAVE the honour to acknowledge the receipt of your Letter of the 10th November last, and to acquaint you, that it does not appear that the late Major Wingfield was authorized to make any Appointments of Non-commissioned Officers;—the Letter of Service for conducting the Recruiting on the Coast of Africa, having declared that he was to be assisted by One Serjeant and Two Corporals from each West India Regiment; a Number which, if present, would no doubt have been fully sufficient for the duty required of them; but as you state, that it was found necessary to detach some of the Serjeants and Corporals of the West India Regiments, in care of the Recruits, and upon other Duties at a distance from the Depôt, I shall not object to admit the proper Charges on account of the Men who were appointed Non-commissioned Officers in the absence of the men so detached. In future, however, such additional Appointments must be limited to supplying the places of the regular Non-commissioned Officers necessarily absent from the Recruiting Depôt, and are to cease upon the return of the latter to their duty. Any Charges made on this account should be supported by your Certificate, that the additional Appointments were actually necessary:
