No money has been paid to the government of Spain, or to any of the subjects thereof, for or on account of any losses sustained in carrying on the Slave Trade.

AN ACCOUNT of all Sums of Money paid to the Governments of Spain or Portugal, for or in consideration of restricting or giving up the Slave Trade.

- AN ACCOUNT of all Sums of Money due to Great Britain from Spain or Portugal, and remitted to the Governments of those Countries, for or in consideration of Losses incurred in the Slave Trade, or for giving up or restricting the same.
- By an Act of 49 Geo. 3, c. 71, a sum of £.600,000 was raised for the service of Portugal, being a part of the loan of that year, and £.895,522. 7s. 9d. three per cent stock was created in respect of the said loan, and the Portuguese government engaged to pay in equal half yearly payments, the sum of £.26,865. 13s.  $5\frac{1}{4}d$ . for interest, the sum of £.30,000 for sinking fund, and the sum of £.304. 9s.  $6\frac{3}{4}d$ . for management upon the said loan.

Those payments were regularly made up to the 5th April 1815, when the sum of £.601,771.7 s. 9 d. of the original capital created remained unredeemed.

By the treaty of 22d January 1815, all further payments from Portugal in respect of the said loan were remitted.

AN ACCOUNT of all Sums of Money received by the Commissioners of the Treasury, or by any person or persons on their behalf, for or on account of any Ships or Cargoes for which compensation has been made to the Owners in pursuance of any Treaties with Spain or Portugal.

1821. January.—Received by William Cotton, Esq. pursuant to the directions of the Lords Commissioners of the Treasury, the amount of proceeds of prizes condemned at Sierra Leone, under the treaties with foreign powers for the prevention of illicit traffic in Slaves, paid into the registry of the mixed commission courts at that settlement - -  $\pounds$  3,703 19 10 $\frac{1}{2}$
