RETURN to an Address of the Honourable The House of Commons, dated 6 June 1848;—for,

"RETURN of the Names of all Vessels adjudicated upon during the last Three Years, in the Mixed Commission Courts at Sierra Leone, Havannah, Surinam, Cape of Good Hope, Jamaica, Cape Verds, and Loanda, with the DATE of such ADJUDICATIONS."
